**“AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO  
MR. NORMAN A. SALAZAR”**

**BE IT ORDAINED**, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:


**SECTION 1.** A Municipal Franchise is hereby granted to **NORMAN A. SALAZAR**, for the operation of One (1) Unit of tricycle along the Route-1 Poblacion, Bantayan, Malobago, Pagsang-an, Lawaan, Ginagdanan Vice versa. And any point of San Roque, Poblacion subject to the following terms and conditions.

A. Validity of the Franchise is one (1) year.

**SECTION 2.** This Ordinance shall take effect upon its approval.
