**“AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO  
MR. JESUS F. DOLORZO”**

**BE IT ORDAINED**, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:


**SECTION 1.A** Municipal Franchise is hereby granted to **JESUS F. DOLORZO**, for the operation of One (1) Unit of tricycle along the Route-1 Poblacion, Bantayan, Malobago, Pagsang-an, Lawaan, Ginagdanan Vice versa. And any point of San Roque, Poblacion subject to the following terms and conditions.


A. Validity of the Franchise is one (1) year.

**APPROVED**, this 26<sup>th</sup> day of February, 2019, at San Roque, Northern Samar, Philippines.


