“AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO MR.ALFREDO P. TUBALLAS”

BE IT ORDAINED, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:

SECTION 1.A Municipal Franchise is hereby granted to **ALFREDO P. TUBALLAS**, for the operation of One (1) Unit of tricycle along the Route-1 Poblacion – Ginagdanan via Bantayan Vice versa. And any point of San Roque, Poblacion subject to the following terms and conditions.

A. Validity of the Franchise is one (1) year.

SECTION 2. This Ordinance shall take effect upon its approval.
