### **“AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO MR. ROGER L. BANTILO.”**

**SECTION 1.A** Municipal Franchise is hereby granted to **ROGER L. BANTILO**, for the operation of One (1) Unit of tricycle along the Route-1 Poblacion – Ginagdanan via Bantayan Vice versa. And any point of San Roque, Poblacion subject to the following terms and conditions.

A. Validity of the Franchise is one (1) year.

**SECTION 2.** This Ordinance shall take effect upon its approval.




