### “AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO MR. PIO S. LOBOS”

**BE IT ORDAINED**, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:

**SECTION 1.A** Municipal Franchise is hereby granted to **PIO S. LOBOS**, for the operation of One (1) Unit of tricycle along the Route-2 Poblacion – Lao-angan Via Dale Vice versa. And any point of San Roque, Poblacion subject to the following terms and conditions.


A. Validity of the Franchise is one (1) year.


