**“AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO MR.ROLDAN N. SORIANO”**


**BE IT ORDAINED**, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:
