“AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO MR. JOEL A. MORALES”

SECTION 1.A Municipal Franchise is hereby granted to **JOEL A. MORALES** for the operation of One (1) Unit of tricycle along the Route-2Poblacion – Lao-angan Via Dale Vice versa. And any point of San Roque,Poblacionsubject to the following terms and conditions.
