## MUNICIPAL ORDINANCE NO. 4

Series of 2019

"AN ORDINANCE ESTABLISHING THE ANTI-CRIMINALITY REWARDS PROGRAM IN THE MUNICIPALITY OF SAN ROQUE, NORTHERN SAMAR"

BE IT ORDAINED, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session, duly assembled, that:

SECTION 1. Short Title. This Ordinance shall be known as the "Anti-Criminality Rewards Program".

SECTION 2. Definition of Terms. The following terms shall mean and be understood/construed as follows:

a) Government means the Local Government Unit of San Roque, or any department or instrumentality of the aforementioned agency;

b) Informant refers to a person who provides privileged information about a person or organization to an agency;

c) Index crimes involve crimes against persons such as murder, homicide, physical injury and rape, and crimes against property such as robbery, theft, carnapping/carjacking and cattle rustling;

- d) Non-index crimes are violations of special laws such as illegal logging or local ordinances;
- e) Vital information shall mean any information, document, book, writing or any other evidence necessary to build up the people's case and/or secure the conviction of criminals.

**SECTION 3. Anti-Criminality Rewards Program (ACRP).** The ACRP will provide reward/s to any such informant who provided vital information leading to the arrest and/or prosecution of a criminal. Grant monetary reward to any such informant shall be provided based on the amounts hereinbelow stated:

- a) For index crimes, the amount of the reward shall be Fifty Thousand Pesos (Php 50,000.00);
- b) For non-index crimes, the amount shall range from Five Thousand Pesos (Php 5,000.00) to Twenty Five Thousand Pesos (Php 25,000.00) depending on the gravity of the crime.

**SECTION 4. Funding Source.** The reward grant shall be taken from the Maintenance and Other Operating Expenses (MOOE) – Public Safety Programs and Activities in order to carry into effect the provisions of this Ordinance.

**SECTION 5. Separability Clause.** The provisions of this Ordinance are hereby declared to be separable, and in the event one or much of such provisions are held unconstitutional, the validity of other provisions shall not be affected thereby.

**SECTION 6. Effectivity.** This Ordinance shall take effect upon its approval.
