**“AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO

**BE IT ORDAINED**, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:

**SECTION 1.A** Municipal Franchise is hereby granted to **MARCIANO G. TUBALLAS, SR.**, for the operation of One (1) Unit of tricycle along the Route-1 Poblacion – Ginagdanan via Bantayan Vice versa. And any point of San Roque, Poblacion subject to the following terms and conditions.


A. Validity of the Franchise is one (1) year.


