“AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO MR. WILFREDO M. MIRAS”


BE IT ORDAINED, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:




