**“AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE HUNDRED TWENTY-FIVE THOUSAND ONE HUNDRED SEVETY-EIGHT PESOS (P525,178.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCE (LBP FORM NO.8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO.01 AS AND FOR THE MOOE-OMOE (FORGOING SUSTAINABLE LOCAL DEVELOPMENT THRU ALLIANCE AND BUILDING,VIBRANT TOURISM INDUSTRY, DISASTER RESILIENCY AND EFFECTIVE COMMUNITY PARTICIPATION), AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.”**

**NOW THEREFORE, BE IT ORDAINED**, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:


**SECTION 1.** The total amount of Five Hundred Twenty-Five Thousand One Hundred Seventy-Eight Pesos (P525,178.00) sourced from the funds stated in the Statement of Funding Source (LBP Form No.8), is hereby appropriated as Supplemental Budget No.01 as and for the MOOE-OMOE (Forgoing Sustainable Local Development Thru Alliance and Building, Vibrant Tourism Industry, Disaster Resiliency and Effective Community participation), and which amount shall be taken from Savings under Other Maintenance and Operating Expenses, that had been automatically reverted to General Fund at the end of Calendar Year 2018.

**SECTION 2.** The disbursement of the foregoing fund shall be in accordance with the existing accounting/ auditing rules and regulations.

**SECTION 3.** This ordinance shall take effect immediately upon its approval.






