**“AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO

BE IT ORDAINED, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:

SECTION 1.A Municipal Franchise is hereby granted to **ARMANDO L. CISNEROS.**, for the operation of One (1) Unit of tricycle along the Route-3 Poblacion – Balnasan - Coroconog via Balud Vice versa. And any point of San Roque, Poblacion subject to the following terms and conditions.


