MUNICIPAL ORDINANCE NO.54S-2020

AN ORDINANCE CREATING A SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) IN THE MUNICIPALITY OF SAN ROQUE, NORTHERN SAMAR.

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. Creation of Special Account in the General Fund (SAGF) for the Bayanihan Grant to Cities and Municipalities, is hereby created in the Municipality of San Roque, Northern Samar.

SECTION 2. Section 313 of Republic Act (RA) No. 7160 otherwise known as the Local Government Code of 1991, mandates the Local Sanggunian to create through an ordinance of a Special Account in the General Fund (SAGF) for the Bayanihan Grant to Cities and Municipalities (BGCM) in their respective Local Government Units (LGUs).

SECTION 3. The allocation from the Bayanihan Grant to Cities and Municipalities (BGCM) amounting to Ten Million One Hundred Thirty-Six Thousand Three Hundred Ten Pesos (Php10,136,310.00) shall be deposited to the Special Account in the General Fund (SAGF) in the Municipality of San Roque, Northern Samar for easy monitoring of the utilization of the allocated fund.

SECTION 4. The fund may be utilized by the municipality for the duration of State of Calamity us declared by the President of the Republic of the Philippines by virtue of Proclamation No. 929 dated March 16, 2020.

SECTION 5. Any ordinance, executive orders, local issuances, rules and regulations or any parts thereof, which are inconsistent with this ordinance are hereby repealed and/or modified accordingly.

SECTION 6. This ordinance shall take effect immediately upon its approval.
