AN ORDINANCE APPROPRIATING THE AMOUNT OF NINE HUNDRED FORTY-FIVE THOUSAND FIVE HUNDRED PESOS (P945,500.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO.8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO.01 AS AND FOR THE MOOE-OMOE (EXPOSURE TRIP TO THE ECONOMICALLY VIBRANT MUNICIPALITIES) AND MOOE-OMOE (GRATUITY PAY OF JOB ORDER EMPLOYEES), AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.
