AN ORDINANCE APPROPRIATING THE AMOUNT OF EIGHT HUNDRED SEVENTY-FIVE THOUSAND PESOS (P875,000.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO.08), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO.02 AS AND FOR THE MOOE-OMOE (PARAYAN FESTIVAL) AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND REGULATION.

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its special session duly assembled that:

SECTION 1. That the amount of Eight Hundred Seventy-Five Thousand Pesos (P875,000.00) sourced from the funds stated in the Statement of Funding and Sources (LBP Form No.08), is hereby appropriated as Supplemental Budget No.02 as and for the MOOE-OMOE (Parayan Festival) in the Office of the Municipal Mayor;

SECTION 2. The disbursement of the foregoing shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provision as accounting/auditing rules and regulations of the provision of R.A 7160 and other issuances governing the same in the disbursement of funds;

SECTION 3. This Ordinance shall take effect immediately upon its approval.
