**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR DON L. ABALON TO ALLOCATE PORTION OF THE LAND OWNED BY THE MUNICIPAL GOVERNMENT OF SAN ROQUE TO BE USED AS AN EVACUATION CENTER AND MULTI-PURPOSE FACILITY OF THE MUNICIPALITY OF SAN ROQUE, NORTHERN SAMAR.**

**WHEREAS**, Republic Act No.10121 otherwise known as "An Act Strengthening The Philippine Disaster Risk Reduction and Management System, Providing for the National Disaster Risk Reduction and Management Framework and Institutionalizing the National Disaster Risk Reduction and Management Plan, Appropriating Funds Therefore and For Other Purposes".

Section 2 par. (g) of RA. No. 10121, provides that it shall be the policy of the State to mainstream disaster risk reduction and climate change in development processes such as policy formulation, socioeconomic development planning, budgeting, and governance, particularly in the areas of environment, agriculture, water, energy, health, education, poverty reduction, land-use and urban planning, and public infrastructure and housing, among others;

**WHEREAS**, Republic Act No.9729, otherwise known as "An Act Mainstreaming Climate Change Into Government Policy Formulations, Establishing the Framework Strategy and Program on Climate Change, Creating For This Purpose The Climate Change Commission, And For Other Purposes;

Section 2 (5<sup>th</sup> par.) of RA. No. 9729 provides that the State recognizes that climate change and disaster risk reduction are closely interrelated and effective disaster risk reduction that will enhance climate change adaptive capacity and the State shall integrate disaster risk reduction into climate change programs and initiatives.

**WHEREAS**, the Local Government Units are tasked to provide adequate evacuation center and other related multi-purpose facilities in preparation for the disaster programs and projects that will immediately response the calamities;

**WHEREAS**, the Municipal Government of San Roque has identified portion of a land owned by the said LGU at Sitio Cabaywa, Barangay Zone 3, San Roque, Northern Samar;

**WHEREAS**, this project aims to help and response the needs of the people of San Roque, especially in the coastal area in times of calamities;

**NOW, THEREFORE**, upon motion made of SB Member Dante C. Tan duly seconded by SB Member Hilario S. Acebuche, **be it..**


