RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS 2ND ENGINEERING DISTRICT OF NORTHERN SAMAR AND THE PROVINCIAL GOVERNMENT OF NORTHERN SAMAR TO INCLUDE IN THEIR ANNUAL PRIORITY LIST OF PROJECTS THE CONSTRUCTION AND IMPROVEMENT OF ALL NON-SURFACED AND DAMAGED ROAD INTERSECTIONS IN THE MUNICIPALITY OF SAN ROQUE, NORTHERN SAMAR.

WHEREAS, Section. 447, par. (5) sub. par. (v) of Republic Act 7160 otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan has the power to regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same; establish bus, and vehicle stops and terminals or regulate the use of the same by privately-owned vehicles which serve the public; regulate garages and the operation and conveyances for hire; designate stands to be occupied by the public vehicles when not in use; regulate the putting of signs, signpost, awnings and awning post on the streets; and provide for the lighting, cleaning and sprinkling of street and public places;



WHEREAS, the Municipality of San Roque non-surfaced and damaged road intersection to and from the main road needs to be surfaced and concreted for a distance of twenty meters (20m) to obviate the effects of dust and muds being carried-on to the main road and protect the road edge cracking and its base from scouring and for the general welfare of the town people;

WHEREAS, those access roads to and from the main roads should be constructed with the standard and correct entrance/exit radius with culvert and catch basin and other appurtenant structures to served as catchment of water curving parallel edge of the road. And, these accesses should be provided with humps 10 meters from the edge of the main road to slow down and provides safety caution to the motorists to the main road;

WHEREAS, the realization of this projects will reduce the dust hazard and muds and provide smooth transition to and from the main road and for the safety of the motorists in particular and the public in general;

NOW THEREFORE, upon motion of SB Member Dante C. Tan duly seconded by SB Member Ethel O. Ramirez, **be it..**

RESOLVES as it is hereby **RESOLVED** to request the Department of Public Works and Highways 2nd Engineering District of Northern Samar and the Provincial Government of Northern Samar to Include In Their Annual Priority List Of Projects The Construction And Improvement Of All Non-Surfaced and Damaged Road Intersections in the Municipality of San Roque, Northern Samar.




