WHEREAS, Section 447, par. (a) sub. par. (1)(iv) of Republic Act 7160 otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan is empowered to adopt measures to protect the inhabitants of the Municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters and calamities to let them be productive in the livelihood following said incidents;

WHEREAS, On 02 December 2019 the Sangguniang Bayan during its regular session declares the Municipality of San Roque, Province of Northern Samar under State of Calamity due to the onslaught of TS "Typhoon Tisoy" thru Resolution No.68 Series of 2019;

WHEREAS, Series of relief operation and assistance were extended to the town people coming from the private organization, government entities and other sectors thru the Municipal Government of San Roque. And that, there's a need for a necessary and immediate rehabilitation of the damaged government properties and structures within the Municipality;






