**WHEREAS**, Sangguniang Bayan Resolution No. 45 Series of 2014, elects Development Bank of the Philippines as a depository bank of the herein municipality;

**WHEREAS**, In order not to delay the financial transactions, the body finds that it is fit and proper to grant authority to Hon. Don L Abalon, the Municipal Mayor and Ms. Evangeline Catherine C. Espina, the Municipal Treasurer, to open and maintain an account with the Development Bank of the Philippines, Catarman Branch, for the General Fund Collections and Special Education Fund;




