SANGGUNIANG BAYAN RESOLUTION NO. 11S-2020

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ATTY. DON L ABALON, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF NATURAL RESOURCES REGIONAL OFFICE VIII FOR THE FORMULATION OF THE FOREST LAND USE PLAN OF THE MUNICIPALITY OF SAN ROQUE, NORTHERN SAMAR.

WHEREAS, the DENR-REGIONAL OFFICE VIII is pursuing the conservation, management, development, protection and proper use of the country's environment and natural resources which primarily aims to curb man-made environmental degradation and mitigate climate change;

WHEREAS, the DENR and LGU are mandated to protect the environment and conserve the natural resources through DENR-DILG JMC No. 1998-01 by incorporating the Forest Land Use Plan (FLUP) into the Municipal Comprehensive Land Use Plan (MCLUP), which was later strengthened in DENR-DILG-LGU JMC No. 2003-01, reiterating the mandate of the LGU to share with the national government the responsibility in the management and maintenance of ecological balance within their territorial jurisdiction;

WHEREAS, the DENR-REGIONAL OFFICE VIII and MLGU shall jointly undertake the formulation of Forest Land Use Planning;

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991 states that; Section 447 (1) (vi) protect the environment and impose appropriate penalties for acts endanger the environment, such as dynamite fishing and other forms of destructive fishing, illegal logging and smuggling of logs, smuggling of natural resources products and of endangered species of flora and fauna, slash and burn farming, and such other activities which result in pollution, acceleration of eutrophication of rivers and lakes or of ecological imbalance;

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991 states that; Section 447 (2) (vii) adopt a comprehensive land use plan for the municipality: Provided, that formulation, adoption or modification of the said plan shall be in coordination with the approved provincial comprehensive land use plan;

NOW THEREFORE, upon motion of SB Member Dante C. Tan, duly seconded by SB Member Freddie F. Jarito, be it...


