WHEREAS, the Annual Investment Plan (AIP) Calendar Year 2020 of the Municipality of San Roque, Northern Samar was duly approved by the Sangguniang Bayan in its Sangguniang Bayan Resolution No.63, series of 2019 and includes the different problems per sector and sub-sector, the work activities and Financial plan for the 20% Development Fund, 5% GAD, 5% DRRM, 1% Senior Citizen, 1% MCPC, Inter-Agency Aides, Statutory and Contractual Obligation, personnel Services, MOOE, Capital outlay and other funds from other sources of agencies;

WHEREAS, the Supplemental Annual Investment Plan 2020 was previously approved and adopted by the Municipal Development Council under MDC Resolution No.01 series of 2020 dated 11 February 2020;

WHEREAS, the Municipal Government Unit of San Roque finds it necessary to implement the various programs, projects and activities embodied in the 2020 Supplemental Annual Investment Plan and Contribute to the attainment of socio-economic development of the Municipality;
