SANGGUNIANG BAYAN RESOLUTION NO.22-s2020

A RESOLUTION GRANTING MS. ANATOLIA GAYTA COTERO A PERMIT TO HOLD A COCKFIGHT ON 16 MARCH 2020 AT SAN ROQUE COCKPIT ARENA AT BARANGAY DALE, SAN ROQUE, NORTHERN SAMAR.

WHEREAS, the Office of the Sangguniang Bayan received a letter request from Ms. Anatolia G. Cotero dated 06 March 2020, granting her a permit to hold a cockfight on 16 March 2020 at the San Roque Cockpit Arena at Barangay Dale, San Roque, Northern Samar;

WHEREAS, Section 5 par. d of PD 449 provides that, except as provided in this Decree, cockfighting shall be allowed only in a licensed cockpits during Sundays and Legal Holidays and during local fiestas for not more than three days. It may also be held during provincial, city or municipal, agricultural, commercial or industrial fair, carnival or exposition for a similar period of three days upon resolution of the province, city or municipality where such fair, carnival or exposition is to be held, subject to the approval of the Chief of Police or his authorized representative;

WHEREAS, on 16 March 2020 is the 60th Founding Anniversary and the Parayan Festival of the Municipality of San Roque, Northern Samar;

WHEREAS, the application of Ms. Anatolia G. Cotero for the renewal of their license to operate and maintain a cockpit at Barangay Dale, San Roque, Northern Samar was approved by the Sangguniang Bayan on 09 March 2020 during its regular session.

NOW THEREFORE, upon motion of SB Member Solidad S. Cagro duly seconded by SB Member Ethel O. Ramirez and SB Member Hilario S. Acebuche, **be it...**


RESOLVES as it is hereby RESOLVED, to grant Ms. Anatolia Gayta Cotero a permit to hold a cockfight on 16 March 2020 at San Roque Cockpit Arena at Barangay Dale, San Roque, Northern Samar.


