WHEREAS, one of the pressing problems that the Municipal Department of Health faces today is the lack of ambulance vehicle that will be used in transporting patients referred to Northern Samar Provincial Hospital or other hospital in Tacloban or Manila;

WHEREAS, presently the Municipal Department of Health has an existing 1 – Unit ambulance being used but then it is not enough to cater the needs of the community and due to wear and tear the said unit experiences mechanical problems;

WHEREAS, the request for additional 1 – Unit ambulance can be of great help in the promotion of basic health services specially to the indigent constituents who cannot afford to hire private vehicle in transporting their patients to the nearest hospital;

WHEREAS, it is but proper and fitting to look for any agency or individual who can extend help and assistance in providing the said needs of the Local Government Unit of San Roque.


