**WHEREAS**, PSA has developed an updated software Philippine Civil Registry Information System (PhilCRIS) to deliver civil registry information management in a new, more user friendly and efficient way;

**WHEREAS**, the PhilCRIS is a software in Windows version of the Civil Registry Information System (CRIS DOS version). This software enables encoding of relevant information from civil registry documents, storage of vital data, query and retrieval of encoded records, printing and issuance of certified copies of encoded civil registry documents, generation of transmittal files, data management and maintenance of the local civil registry database;


**WHEREAS**, the use of PhilCRIS will enable the Local Government Unit (LGU) to print preview and print directly to the 2007 civil registry forms;

**NOW THEREFORE**, upon motion of SB Member Hilario S. Acebuche, duly seconded by all the members of the Sangguniang Bayan present, **be it...**




