SANGGUNIANG BAYAN RESOLUTION NO.26-S2020

RESOLUTION DECLARING THE ENTIRE MUNICIPALITY OF SAN ROQUE, NORTHERN SAMAR UNDER A STATE OF CALAMITY DUE TO PUBLIC HEALTH EMERGENCY CAUSED BY COVID-19.

WHEREAS, Under Section 15, Article II of the Philippine Constitution, it is the State's Policy to protect and promote the right to health of the people;

WHEREAS, Section 16, of Republic Act (RA) No. 7160 otherwise known as the Local Government Code of 1991, provides that within their respective territorial jurisdictions, Local Government Units shall promote the health and safety of the inhabitants;

WHEREAS, Section 7 of Republic Act (RA) No. 11332 provides that the Secretary of Health shall have the authority to declare epidemics of national and/or international concerns;

WHEREAS, the Secretary of Health has confirmed the local transmission of Corona Virus Disease (Covid-19) in the Philippines;


WHEREAS, the declaration of a State of Calamity due to Public Health Emergency caused by Covid-19 would capacitate the Local Government Unit of San Roque, Northern Samar to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of Covid-19, mitigate its effects and impact to the community, and prevent serious disruption of the functioning of the government and the community;


NOW THEREFORE, upon motion of SB Member Hilario S. Acebuche duly seconded by all the members of the Sangguniang Bayan present, **be it...**




RESOLVED FURTHER, that copies of this resolution be furnished to the Office of the Mayor, Other Offices Concerned and Office File for their Information.
