**“AN ORDINANCE GRANTING MUNICIPAL FRANCHISE TO MR.GREGORIO A. MEJOS.”**

BE IT ORDAINED, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:

**SECTION 1.** A Municipal Franchise is hereby granted to **GREGORIO A. MEJOS.**, for the operation of One (1) Unit of tricycle along the Route-1 San Roque,-Bantayan, Malobago, Pagsang-an, Lawaan Ginagdanan Vice versa. And any point of San Roque, Poblacion subject to the following terms and conditions.

A. Validity of the Franchise is one (1) year.

**SECTION 2.** This Ordinance shall take effect upon its approval.


