"A RESOLUTION DECLARING FOR THE SUSPENSION OF THE TRIAL HEARING OF ADMINISTRATIVE CASE NO. 01-2018 AND ADMINISTRATIVE CASE NO. 02-2018 ALL FOR OPPRESSION, DISHONESTY, GRAVE MISCONDUCT IN OFFICE, GRAVE ABUSE OF AUTHORITY, GROSS NEGLIGENCE OR DERELICTION OF DUTY"


WHEREAS, the Sangguniang Bayan will be holding a special session on January 16, 2019 for the continuing trial hearing of the Administrative cases No. 01-2018, and No. 02-2018, for Oppression, Dishonesty, Grave Misconduct in Office, Grave Abuse of Authority, Gross Negligence or Dereliction of Duty filed by the complainants Maricel F. Tubelleza and Maria F. Cisneros against the respondent Barangay Captain Diosdado M. Diaz, Jr.;

WHEREAS, in pursuant to COMELEC Resolution No. 10429, dated October 1, 2018 declaring January 13, 2019 to June 12, 2019 as an election period, and one of the prohibited activities is the suspension of an elective local officials, as provided for under section 261 (x) of the Omnibus Election Code, and section 62 (c) of R.A. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Sangguniang Bayan members who were present during the special session agreed to declare for the suspension of the scheduled hearing of the Administrative Cases No. 01-2018 and No. 02-2018 on January 16, 2019, and trial hearing will resume after the lifting of an election period;

WHEREAS, notice for the schedule of hearing will be issued by this Sangguniang Bayan acting as Quasi-Judicial body to both complainants and the respondent after June 12, 2019.

NOW, THEREFORE, upon motion of all members who were present, be it



RESOLVED FURTHER, that copies of this resolution be furnished to complainants, respondent and file;


