WHEREAS, the Department of Information Technology (DICT) is an Executive Branch of the Government aims to bridge the digital device by establishing Tech4Ed Center under Digital Program, which will enhance the Socio-Economic condition of Filipinos and provide inclusive growth of the country;

WHEREAS, establishment of Tech4Ed Project aims to cater the Out-of-School Youths and Adults (OSYA), women, teachers, Overseas Workers (OWA) including their families and relatives, Person with Disabilities (PWD), Senior Citizens, indigenous people, and entrepreneurs as the target beneficiaries or END USERS;

WHEREAS, there is a need to authorize the Municipal Mayor as representative of the Local Government Unit of the Municipality of San Roque, Northern Samar to enter into a Memorandum of Agreement with the Department of Information and Communication (DICT) for the establishment of the Tech4Ed Center and for other purposes;
