**“A RESOLUTION ADOPTING THE VISION, MISSION, GOALS AND OBJECTIVES OF THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) OF THE MUNICIPALITY OF SAN ROQUE, NORTHERN SAMAR.”**

**WHEREAS**, the Department of Transportation (DOTr), through Department Order No. 2617-011, otherwise known as the Omnibus Guidelines in the Planning and Manifestation of Public Road Transportation Services and Franchise Issuance, shifted the determination and provision of public transportation services from the private sector to the public sector;

**WHEREAS**, Public transport is a very important component of a municipality's transportation system because it serves majority of rural travellers;

**WHEREAS**, the Municipality of San Roque, Northern Samar has identified various important routes within the municipality which are significant in the case of transportation in one place to another and will be beneficial to several transport services in order to reach out to more people who need them for their daily travel and economic activities;


**WHEREAS**, during the 1<sup>st</sup> Joint MDC-MPOC-MADAC meeting, the vision, mission, goals and objectives of the Local Public Transport Route (LPTRP) was presented which reads as follows:

***VISION***

*“By the year 2023, San Roque, Northern Samar will have a sustainable rural routes that will cater the needs of the transporting people with ease of access of transportation system for economic and development activities.”*

***MISSION***

*“To contain and cope up with the economic and well-being of the people with an accessible transportation facilities to cater economic and development activities of the people.”*



In support of the municipality's vision and mission, three equally important goals were crafted, its follows:

- i. Improve public transport system
- ii. Improve transport management
- iii. Enhance transport equity

The objectives of the Local Public Transport Route Planning are enumerated as follows:


- i. To strengthen the enforcement of traffic authorities on intersections without traffic signalization system;
- ii. To provide and create public terminal for transportation;
- iii. To prepare a major legislative act to regulate the local transportation system, and
- iv. To undertake a study on the feasibility of establishing an Integrated Terminal Transport System in the municipality.


**NOW THEREFORE**, upon motion of SB Member Alvin M. Lagrimas duly seconded by SB Member Jocelyn U. Curso, be it . .


