**WHEREAS,** pursuant to Section 445 (a) (1) Article Two Book III, of Republic Act No. 7160, the Municipal Vice Mayor shall be the presiding Officer of the Sangguniang Bayan and sign all warrants drawn on the municipal treasury for all expenditures appropriated for the operation of the Sangguniang Bayan;

**NOW THEREFORE,** upon motion of SB Member Alvin M. Lagrimas duly seconded by SB Member Ethel O. Ramirez, be it;




