**WHEREAS**, the FIRST PARTY has no existing Bids and Awards Committee (BAC) as its own and requesting the SECOND PARTY to allow the former to use for matters relating to the procurement of goods and services, infrastructure and civic works and consultancy services.

**NOW THEREFORE**, for consideration of the foregoing agreement on motion made by SB Member Hilario S. Acebuche, duly seconded by SB Member Ethel O Ramirez, be it...






