

“A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, DON L ABALON, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ECO SEA COMPANY LTD. FOR THE INSTALLATION OF WASTE TREATMENT FACILITY AND/OR WASTE TO ENERGY FACILITY”

WHEREAS, ECO SEA COMPANY LTD. is a domestic partnership engaged primarily in the processing of biodegradable, non-biodegradable, and domestic waste;

WHEREAS, the Municipal Government of San Roque, Northern Samar is a municipal corporation whose powers and functions to engage in business are defined under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, with responsibilities for solid waste management under Republic Act No. 9003;


WHEREAS, ECO SEA COMPANY LTD. expressed willingness to provide the necessary equipment and technology, specifically a WASTE TREATMENT FACILITY and/or WASTE TO ENERGY FACILITY, to address the problem on waste management in San Roque, Northern Samar, and cater all other municipalities in the Province of Northern Samar, and the LGU has likewise expressed its willingness to let and/or lease, and/or otherwise provide on temporary basis, to the company a suitable site for the installation of WASTE TREATMENT FACILITY and/or WASTE TO ENERGY FACILITY;


RESOLVED FURTHER, that a copy of this resolution be furnished to ECO SEA COMPANY LTD, for their information and action.




