MUNICIPAL ORDINANCE NO. 105 S, 2020

AN ORDINANCE PRESCRIBING MANDATORY COMPLIANCE WITH ALL THE GUIDELINES, RULES AND REGULATIONS PROMULGATED BY THE INTER-AGENCY TASK FORCE ON THE EMERGING INFECTIOUS DISEASES, AS WELL AS BY THE LOCAL INTER-AGENCY TASK FORCES, AND WITH ALL EXECUTIVE ORDERS ISSUED BY THE PROVINCIAL GOVERNOR AND THE MUNICIPAL MAYOR, IN RELATION TO THE PREVENTION AND CONTROL OF COVID-19, PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES

WHEREAS, Section 15, Article II of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, President Rodrigo R. Duterte issued Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines; and Proclamation No. 929 declaring a State of Calamity throughout the country due to continuous rise of COVID-19 cases;

WHEREAS, DILG Memorandum Circular No. 2020-067 April 2, 2020, directing all LGUs to fully establish and activate their respective Local Task Force Against COVID-19 and align all their actions with national strategy framework; and in relation therewith, Mayor Don L Abalon issued Executive Order No 2020-4-02 activation of the Local Task Force against COVID -19 which define the role of the Composite Team to effectively facilitate intersectional collaboration to establish the preparedness and ensure efficient government response to assess, monitor contain control and prevent the local spread of COVID -19;

WHEREAS, there are certain guidelines, rules and regulations promulgated by the Inter-Agency Task Force on the Emerging Infectious Diseases, as well as by the Regional, Provincial and Municipal IATF, and likewise executive orders issued by the Provincial Governor and the Municipal Mayor, for the control and/or prevention of the spread of Covid-19;

WHEREAS, these guidelines, rules and regulations, and executive orders need to be legislated in order to have the full force and effect that they are designed to attain, with the corresponding penalties imposed for any violation thereof;

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar in its regular session duly assembled that:

Section 1. Mandatory Compliance. Every person residing in or found within the territorial jurisdiction of the Municipality of SanRoque, Northern Samar, shall, at all times, comply and/or obey all the provisions in the guidelines, and in the rules and regulations, promulgated by the Inter-Agency Task Force on the Emerging Infectious Diseases, as well as those promulgated by the regional, provincial and/or municipal IATF, as well as of the executive orders issued by the Provincial Governor or the Municipal Mayor, in relation or pertaining to the control or prevention of Covid-19, whenever applicable to the peculiar situation of the locality.

Sec. 2. Penalty. Any person who violates any provision of any such guideline, rule or regulation, or of any such executive order, shall suffer the penalty of fine in the amount of five hundred pesos (P500.00) for the first offense; the penalty of fine in the amount of one thousand pesos (P1000.00) for the second offense; and the penalty of fine in the amount of two thousand pesos (P2500.00) and imprisonment of one (1) month for the third and each succeeding offenses. Whenever there exists an ordinance prescribing a higher penalty for a particular violation, the penalty imposable under such ordinance shall be imposed, but in no case shall it exceed two thousand five hundred pesos, unless the offender shall be prosecuted under such ordinance. The offender, should he intends to avoid criminal prosecution, may pay the corresponding fine administratively and render community service for eight (8) hours.

Sec. 3. Separability Clause. If for any reason, a part of this Ordinance is declared unconstitutional, ultra vires, inoperative, or otherwise illegal or invalid, other parts or provisions hereof that are not affected thereby shall remain valid and in full force and effect.

Sec. 4. Effectivity Clause. This Ordinance shall take effect fifteen (15) days after its publication.

RESOLVED FURTHER, that a copy of this ordinance be furnished to the offices/agencies concerned and file.


