MUNICIPAL ORDINANCE NO. 106 S, 2020

AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (Php500,000.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM No. 8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO. 31 AS AND FOR THE MOOE-COLLECTIVE NEGOTIATION AGREEMENT – INCENTIVE IN THE OFFICE OF THE MUNICIPAL ADMINISTRATOR AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that;

SECTION 1. APPROPRIATION. The amount of Five Hundred Thousand Pesos (Php500,000.00) sourced from the funds stated in the statement of Funding Sources (LBP Form No.8), form an integral parts of this Ordinance is hereby appropriated as Supplemental Budget No.31 as stated to cover the;

- 1. Collective Negotiation Agreement – Incentive Php500,000.00
In the Office of the Municipal Administrator

SECTION 2. PURPOSE. The amount of Five Hundred Thousand Pesos (Php500,000.00) is intended for the Collective Negotiation Agreement – Incentive in the Office of the Municipal Administrator.


SECTION 3. DISBURSEMENT. The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/auditing rules and regulations of the provision of R.A. 7160 and other issuances governing the same in the disbursement of funds.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.




