**AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM No. 8) IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET No. 36 AS AND FOR THE CAPITAL OUTLAY-INSTALLATION OF 37.5 EXCLUSIVE TRANSFORMER AND OTHER MACHINERY AND EQUIPMENT (PRESSURIZED WATER PUMP) IN THE LEGISLATIVE DEPARTMENT AS STATED IN THE LBP FORM NO. 09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.**

**BE IT ENACTED**, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

**SECTION 1. APPROPRIATION** – The amount of Two Hundred Fifty Thousand Pesos (P250,000.00) sourced from the funds stated in the statement of funding and sources (LBP Form No. 8) form an integral part of this ordinance is hereby appropriated as supplemental Budget No. 36 as stated to cover the;

**SECTION 2. PURPOSE.** The amount of Two Hundred Fifty Thousand Pesos (P250,000.00) is intended for the Capital Outlay-Installation of 37.5 Exclusive Transformer and other Machinery and Equipment (Pressurized Water Pump) in the Legislative Department.

**SECTION 3. DISBURSEMENT.** The disbursement of the foregoing fund shall be the responsibility of the Municipal Vice Mayor to comply with the existing provisions on accounting/auditing rules and regulations of the provision of R.A. 7160 and other issuances governing the same in the disbursement of funds.

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect immediately upon its approval.


