AN ORDINANCE APPROPRIATING THE AMOUNT OF FIFTY THREE THOUSAND THIRTY-EIGHT PESOS AND 54/100 (P53,038.54) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO. 8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO. 37 AS AND FOR THE HONORARIUM OF BAC MEMBERS, TECHNICAL WORKING GROUP, BAC SECRETARY AND BAC SECRETARIAT STAFF IN THE BAC SECRETARIAT OFFICE AS STATED IN THE LBP FORM NO. 09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES

**BE IT ENACTED,** by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. APPROPRIATION. The amount of Fifty Three Thousand Thirty-Eight Pesos and 54/100 (P53,038.54) sourced from the funds stated in the statement of funding and sources (LBP Form No. 8) form an integral part of this ordinance is hereby appropriated as Supplemental Budget No. 37 as stated to cover the:

1. MOOE-Honorarium of BAC Members, Technical Working Group, BAC Secretary, and BAC Secretariat Staff - P53,038.54 In the BAC Secretariat Office

**SECTION 2. PURPOSE.** The amount of Fifty Three Thousand Thirty-Eight Pesos and 54/100 (53,038.54) is intended for the MOOE-Honorarium of BAC Members, Technical Working Group, BAC Secretary and BAC Secretarial Staff in the BAC Secretariat Office.

SECTION 3. DISBURSEMENT. The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/auditing rules and regulations on the provisions of R.A. 7160 and other issuances governing the same in the disbursement of funds.

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.
