AN ORDINANCE APPROPRIATING THE AMOUNT OF FIFTY THREE THOUSAND THIRTY-EIGHT PESOS AND 54/100 (P53,038.54) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO. 8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO. 37 AS AND FOR THE HONORARIUM OF BAC MEMBERS, TECHNICAL WORKING GROUP, BAC SECRETARY AND BAC SECRETARIAT STAFF IN THE BAC SECRETARIAT OFFICE AS STATED IN THE LBP FORM NO. 09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES




