MUNICIPAL ORDINANCE NO. 116 S, 2020

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED THIRTY THOUSAND PESOS (P130,000.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO. 8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO. 38 AS AND FOR THE MOOE-DONATION (SOCIAL AMELIORATION PROGRAME-AICS) BURIAL ASSISTANCE IN THE MUNICIPAL DEPARTMENT OF SOCIAL SERVICES AND HUMAN PROTECTION AS STATED IN THE LBP FORM NO. 09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. APPROPRIATION. The amount of One Hundred Thirty Thousand Pesos (P130,000.00) sourced from the funds stated in the statement of funding and sources (LBP Form No. 8) form an integral part of this ordinance is hereby appropriated as Supplemental Budget No. 37 as stated to cover the:

- 1. Donation (Social Amelioration Program-AICS) Burial Assistance - Php130,000.00
In the Municipal Department of Social Services and Human Protection

SECTION 2. PURPOSE. The amount of One Hundred Thirty Thousand Pesos (P130,000.00) is intended for the MOOE-Donation (Social Amelioration Program-AICS) Burial Assistance in the Municipal Department of Social Services and Human Protection.

SECTION 3. DISBURSEMENT. The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/auditing rules and regulations on the provisions of R.A. 7160 and other issuances governing the same in the disbursement of funds.

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.




