MUNICIPAL ORDINANCE NO. 118 S, 2020

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO. 8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO. 40 AS AND FOR THE OTHER PERSONNEL BENEFITS-SERVICE RECOGNITION INCENTIVE, AS STATED IN THE LBP FORM NO. 09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

WHEREAS, the President of the Republic of the Philippines, Rodrigo Roa Duterte issued an Administrative Order No. 37 dated December 18, 2020, authorizing the grant of Service Recognition Incentive (SRI) to government employees for fiscal year (FY) 2020;

WHEREAS, the DBM has recommended updating the policies on and levels of incentives applicable to all government personnel through the grant of a one-time incentive, to recognize and further encourage the unwavering commitment and dedication of government employees in performing their work, their continued support and collaborative efforts in the delivery of services to the public, as well as their diligence in the effective and efficient performance of their functions;

WHEREAS, government employees deserve to be rewarded for their collective and unceasing participation in and invaluable contribution to the Administration's continuing efforts toward the establishment of streamlined government processes and more responsible delivery of public services, especially in the midst of the public health emergency caused by the COVID-19 pandemic; and

WHEREAS, a certification as to the availability of fund was issued by the Local Financed Committee of the Municipal Government of San Roque, Northern Samar;

NOW THEREFORE, BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its special session duly assembled that:

SECTION 1. There is hereby appropriated the total amount of One Million Pesos (P1,000,000.00) sources from the funds stated in the Statement of Funding Sources (LBP Form No. 8), is hereby appropriated as Supplemental Budget No. 40 as and for the Personnel Benefits-Service Recognition Incentive.

SECTION 2. The disbursement of the foregoing fund shall be in accordance with the existing accounting/auditing rules and regulations.

SECTION 3. This ordinance shall take effect immediately upon its approval.




