**AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR MILLION THREE HUNDRED THOUSAND PESOS (P4,300,000.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO.08), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO.03 AS AND FOR THE MOOE-OMOE, MOOE-OMOE (PURCHASE OF DISINFECTANTS/ HYGIENE KITS FOR DISTRIBUTION) AND MOOE-OMOE(FINANCIAL AND OTHER ASSISTANCE DURING EMERGENCY), AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.**

**SECTION 1.** That the amount of Four Million Three Hundred Thousand (P4,300,000.00) sourced from the funds stated in the Statement of Funding Sources (LBP Form No.08), is hereby appropriated as Supplemental Budget No.03 as and for;




