AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR MILLION THREE HUNDRED THOUSAND PESOS (P4,300,000.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO.08), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO.03 AS AND FOR THE MOOE-OMOE, MOOE-OMOE (PURCHASE OF DISINFECTANTS/ HYGIENE KITS FOR DISTRIBUTION) AND MOOE-OMOE(FINANCIAL AND OTHER ASSISTANCE DURING EMERGENCY), AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its Special Session duly assembled that:

SECTION 1. That the amount of Four Million Three Hundred Thousand (P4,300,000.00) sourced from the funds stated in the Statement of Funding Sources (LBP Form No.08), is hereby appropriated as Supplemental Budget No.03 as and for;

 MOOE-Other Maintenance and Operating Expenses-Office of the Municipal Mayor

- P 400,000.00

2. MOOE-OMOE- (Purchase of disinfectants/ hygiene kits for distribution) Municipal Department of Health

- P1,900,000.00

 OMOE-Financial and Other Assistance during Emergency-Municipal Department of Social Services And Human Protection

- P2,000,000.00

SECTION 2. The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/ auditing rules and regulations of the provision of R.A. 7160 and other issuances governing the same in the disbursement of funds;

SECTION 3. This ordinance shall take effect immediately upon its approval.
