**SECTION 1.** That the amount of Ten Million One Hundred Thirty-Six Thousand Three Hundred Ten Pesos (P10,136,310.00) sourced from the funds stated in the Statement of Funding Sources (LBP Form No.8), is hereby appropriated as Supplemental Budget No.06 as and for;

1. MOOE-Welfare Goods Expenses  
(Municipal Department of Social Services  
and Human Protection)

*2<sup>nd</sup> Wave:* **P 4,450,000.00** P8,318,819.00
2. MOOE- Purchase of Medicines and Vitamins  
(Municipal Department of Health) 562,191.00
3. MOOE- Medical/Clinical and Other Supplies Intended  
for Community Isolation Unit-  
(Municipal Department of Health) 1,255,300.00

**SECTION 2.** The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/ auditing rules and regulations of the provision of R.A 7160 and other issuances governing the same in the disbursement of funds;

**SECTION 3.** This ordinance shall take effect immediately upon its approval.


