AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO HUNDRED SEVEN THOUSAND SIX HUNDRED PESOS (P207,600.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO.8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO.09 AS AND FOR THE PROVISION OF FOOD ASSISTANCE TO SENIOR CITIZENS AND DIFFERENTLY-ABLED PERSONS AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING **RULES AND PROCEDURES.**

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:

SECTION 1. That the amount of Two Hundred Seven Thousand Six Hundred Pesos (P207,600.00) sourced from the funds stated in the Statement of Funding Sources (LBP Form No.8), is hereby appropriated as Supplemental Budget No.09 as and for Provision of Food Assistance to Senior Citizens and Differently-Abled Persons in the Municipal Department of Social Services and Human Protection;

SECTION 2. The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/ auditing rules and regulations of the provision of R.A 7160 and other issuances governing the same in the disbursement of funds;

SECTION 3. This ordinance shall take effect immediately upon its approval.
