AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION ONE HUNDRED SEVENTY-FIVE THOUSAND FOUR HUNDRED FORTY PESOS (P1,175,440.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO. 8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO. 11 AS AND FOR THE MOOE-OMOE (INCENTIVE OF PREGNANT WOMEN WHO GAVE BIRTH IN SAN ROQUE RURAL HEALTH UNIT/OTHER HEALTH FACILITIES) AND MOOE-OMOE-INCENTIVE OF BHWS RETIREES IN THE MUNICIPALITY DEPARTMENT OF HEALTH AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. APPROPRIATION. That the amount of One Million One Hundred Seventy-Five Thousand Four Hundred Forty Pesos (P1,175,440.00) sourced from the funds stated in the statement of funding and sources (LBP Form No. 8), form and integral part of this Ordinance is hereby appropriated as Supplemental Budget No. 11 as stated to cover the following:

 OMOE-Incentive of Pregnant Women Who Gave Birth in San Roque Rural Health Unit/Other Health Facilities (Municipal Department of Health)

P580,000.00

2. OMOE-Incentive of BHWs Retirees (Municipal Department of Health)

P595,440.00

SECTION 2. PURPOSE. The amount of Five Hundred Eighty Thousand Pesos (P580,000.00) shall cover the incentive for Pregnant Women Who Gave Birth in San Roque Rural Health Unit and other Health Facilities from January 1, 2017 up to Present and the amount of Five Hundred Ninety-Five Thousand Four Hundred Forty Pesos (P595,440.00) as Incentive of BHWs Retirees who are 60 years old and above;

SECTION 3. DISBURSEMENT. The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/auditing rules and regulations of the provision of R.A. 7160 and other issuances governing the same in the disbursement of funds;

SECTION 4. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.
