MUNICIPAL ORDINANCE NO. 67S-2020

AN ORDINANCE AMENDING ARTICLE 33, SECTION 7 PARAGRAPH C OF MUNICIPAL ORDINANCE NO. 79, SERIES OF 2019 AND FOR OTHER PURPOSES.

WHEREAS, the Municipal Government adopted a policy of collaborative cooperation with its component barangays, with an end-view of fast tracking barangay development;

WHEREAS, geared towards the attainment of the foregoing objectives, the Municipal Government appropriated certain amount as and for the Inter-LGU Cooperative Fund whereby each barangay will receive from the Municipal Government the sum of Two Hundred Thousand Pesos (P200,000.00) each, subject to certain conditions and requirements prescribed in the second paragraph of Article 33, Section 7 of Municipal Ordinance No. 79, series of 2019, among which is "(c) at least 2% of the total population participated the Bloodletting Activities";

WHEREAS, in view of the current COVID-19 crisis, bloodletting activities had been suspended, have it become impossible for the barangay to comply with their requirement, necessitating its deferment.

NOW THEREFORE, BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its Regular Session duly assembled that:

Section 1. Article 33, Section 7 of Municipal Ordinance No. 79 series of 2019, is hereby amended as follows:

Article 33. ECONOMIC DEVELOPMENT FUND - The amount of P24,400,000.00 of the appropriations in Article 2 hereof, equivalent to at least 20% on the Internal Revenue Allotment shall be reserved and utilized as and for the Economic Development Fund for various programs, projects, activities and services embodied in the Annul Investment Plan for CY 2020.

The Projects, Programs and Activities under the 20% Economic Development Fund includes Inter-LGU Cooperation Fund wherein the 16 Barangays will be granted Two Hundred Thousand Pesos (P200,000.00) each provided that they will comply with the following conditions, to wit;

- (a) 0% COA Disallowances, Charges and Suspension;
- (b) Sustainability of Drug Free Barangay;
- (c) Attendance to all Council Meeting;
- (d) At least 90% Compliance of Waste Segregation;
- (e) Approved Financial Statement for the Preceding;
- (f) Approved Barangay Investment Plan;
- (g) 100% Completeness of All Barangay Plans;

The Municipal Mayor is hereby authorized to allocate so much amount from the savings of the programs, projects, activities and services funded under this fund and utilize the same for other programs, projects, activities and services indicate in the Annual Investment Plan: Provided, that such, other programs projects, activities and services to which the savings may be allocated and/or utilized are not among those prohibited to be funded from the Economic Development Fund.

Section 2. REPEALING CLAUSE - All ordinances, resolutions, orders, memoranda and other issuances not inconsistent herewith are hereby repealed or modified accordingly.

Section 3. SEPARABILITY CLAUSE - If, for any reason, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 4. EFFECTIVITY - This ordinance shall take effect immediately upon its approval.
