MUNICIPAL ORDINANCE NO.70-S2020

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION FOUR HUNDRED FIFTY THOUSAND PESOS (P1,450,000.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING SOURCES (LBP FORM NO.8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO.13 AS AND FOR THE PERSONAL SERVICES - OTHER PERSONNEL BENEFITS (PERFORMANCE-BASED BONUS), AS STATED IN THE LBP FORM NO.09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. APPROPRIATION. The amount of One Million Four Hundred Fifty Thousand Pesos (P1,450,000.00) sourced from the funds stated in the Statement of Funding Sources (LBP Form No.8), form an integral part of this ordinance is hereby appropriated as Supplemental Budget No.13 as stated to cover the:

- 1. Personal Services-Other Personnel Benefits (Performance-Based Bonus) - ₱1,450,000.00
In the Office of the Municipal Administrator.

SECTION 2. PURPOSE. The amount of One Million Four Hundred Fifty Thousand Pesos (₱1,450,000.00) shall cover the Personal Services-Other Personnel Benefits (Performance-Based Bonus).

SECTION 2. DISBURSEMENT. The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/ auditing rules and regulations and the provision of Republic Act (R.A.) 7160 and other issuances governing the same in the disbursement of funds.


SECTION 3. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.




