AN ORDINANCE APPROPRIATING THE AMOUNT OF EIGHT MILLION SEVEN HUNDRED FIFTY-NINE THOUSAND SIX HUNDRED EIGHT PESOS (P8,759,608.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO. 8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO. 15 AS AND FOR THE VARIOUS PROJECTS, PROGRAMS AND ACTIVITIES, AS STATED IN THE LBP FORM NO. 09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

SECTION 1. APPROPRIATION. The amount of Eight Million Seven Hundred Fifty-Nine Thousand Six Hundred Eight Pesos (P8,759,608.00) sourced from the funds stated in the Statement of Funding Sources (LBP Form No. 8), form an integral part of this ordinance is hereby appropriated as Supplemental Budget No. 15 as stated to cover the following;




