**AN ORDINANCE APPROPRIATING THE AMOUNT OF SEVEN HUNDRED NINETY-EIGHT THOUSAND TWO HUNDRED PESOS (P798,200.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO. 8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO. 16 AS AND FOR THE MOOE – OTHER SUPPLIES AND MATERIAL EXPENSES, MOOE-OTHER MAINTENANCE AND OPERATING EXPENSES AND CAPITAL OUTLAY – OFFICE EQUIPMENT, AS STATED IN THE LBP FORM NO. 09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.**

**BE IT ENACTED**, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

**SECTION 1. APPROPRIATION.** The amount of Seven Hundred Ninety-Eight Thousand Two Hundred Pesos (P798,200.00) sourced from the funds stated in the Statement of Funding Sources (LBP Form No. 8), form an integral part of this ordinance is hereby appropriated as Supplemental Budget No. 16 as stated to cover the following;

1. Other Supplies and Material Expenses In the Legislative Department	-	P185,200.00
2. Other Maintenance and Operating Expenses In the Legislative Department	-	45,000.00
3. Capital Outlay – Office Equipment In the Legislative Department	-	568,000.00
<b><u>TOTAL</u></b>	<b>-</b>	<b><u>P798,200.00</u></b>

**SECTION 2. PURPOSE.** The amount of Seven Hundred Ninety-Eight Thousand Two Hundred Pesos (P798,200.00) shall cover the MOOE – Other Supplies and Material Expenses, MOOE – Other Maintenance and Operating Expenses and Capital Outlay – Office Equipment in the Legislative Department in the Municipality of San Roque, Northern Samar.

**SECTION 3. DISBURSEMENT.** The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/auditing rules and regulations of the provision of R. A. 7160 and other issuances governing the same in the disbursement of funds.


