**AN ORDINANCE APPROPRIATING THE AMOUNT OF THIRTY-TWO THOUSAND PESOS (P32,000.00) SOURCED FROM THE FUNDS STATED IN THE STATEMENT OF FUNDING AND SOURCES (LBP FORM NO. 8), IS HEREBY APPROPRIATED AS SUPPLEMENTAL BUDGET NO. 18 AS AND FOR THE CONCRETING/CEMENTING ALONG INILIAN-GALUTAN-BURAC-COROCONOG-HIMABUG-AT FMR (EXTRA WORK), AS STATED IN THE LBP FORM NO. 09 AND MADE INTEGRAL PARTS HEREOF, SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.**

**BE IT ENACTED**, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

**SECTION 1. APPROPRIATION.** The amount Thirty-Two Thousand Pesos (P32,000.00) sourced from the funds stated in the Statement of Funding Sources (LBP Form No. 8), form an integral part of this ordinance is hereby appropriated as Supplemental Budget No. 18 as stated to cover the;

- 1. Concreting/Cementing Along Inilian-Galutan-Burac-Coroconog-Himabug-at (EXTRA WORK) - P32,000.00  
In the Municipal Department of Engineering and Public Works


**SECTION 2. PURPOSE.** The amount Thirty-Two Thousand Pesos shall cover the additional funding for the Concreting/Cementing along Inilian-Galutan-Burac-Coroconog-Himabug-at (Extra Work) in the Municipal Government of San Roque, Northern Samar.

**SECTION 3. DISBURSEMENT.** The disbursement of the foregoing fund shall be the responsibility of the Local Chief Executive (LCE) to comply with the existing provisions on accounting/auditing rules and regulations of the provision of R. A. 7160 and other issuances governing the same in the disbursement of funds.

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect immediately upon its approval.
