MUNICIPAL ORDINANCE NO. 78-S2020

AN ORDINANCE AMENDING FURTHER ARTICLE 33, PARAGRAPH 2, SECTION 7, OF MUNICIPAL ORDINANCE NO. 79 SERIES OF 2019, AND FOR OTHER PURPOSES.

WHEREAS, the Municipal Government adopted a policy of collaborative cooperation with its component barangays, with an end-view of fast tracking barangay development;

WHEREAS, geared towards the attainment of the foregoing objectives, the Municipal Government appropriated certain amount as and for Inter-LGU Cooperative Fund whereby each barangay will receive from the Municipal Government the sum of One Hundred Seventy Eight Thousand Four Hundred Thirty Seven Pesos and Fifty Centavo (P178,437.50) each, subject to certain conditions and requirements prescribed in the second paragraph of Article 33, Section 7, of Municipal Ordinance No. 79, series of 2019;

WHEREAS, in view of the current COVID-19 crisis, bloodletting activities had been suspended, have it become impossible for the barangay to comply with the requirement, necessitating its deferment.

BE IT ENACTED, by the Sangguniang Bayan of San Roque, Northern Samar during its regular session duly assembled that:

Section 1. Article 33, Section 7, of Municipal Ordinance No. 79, series of 2019, is hereby amended as follows:

Article 33. ECONOMIC DEVELOPMENT FUND – *The amount of P24,400,000.00 of the appropriations in Article 2 hereof, equivalent to at least 2% on the Internal Revenue Allotment shall be reserved and utilized as and for the Economic Development Fund for various programs, projects, activities and services embodied in the Annual Investment Plan for Calendar Year 2020.*

The Projects, Programs and Activities under 20% Economic Development Fund includes Inter-LGU Cooperation Fund wherein the 16 Barangays will be granted One Hundred Seventy-Eight Thousand Four Hundred Thirty Seven Pesos and Fifty Centavo (P178,437.50) each provided that they will comply with the following conditions, to wit;

- (a) Copies of Pertinent Documents for the Processing of Work Accomplished;
- (b) Sustainability of Drug Free Barangay;
- (c) Attendance to All Council Meetings;
- (d) Compliance of Waste Segregation;
- (e) Approved Financial Statement for the Preceding Year;
- (f) Approved Barangay Investment Plan

The amount to be downloaded will be divided into tranches depending on the process of the billing for the work accomplished, until the project is 100% completed.


The Municipal Mayor is hereby authorized to allocate so much amount from the savings of the programs, projects, activities and services funded under this fund and utilize the same for the other programs, projects, activities and services indicate in the Annual Investment Plan; Provided, that such, other programs, projects, activities to which the savings may be allocated and/or utilizes are not among those prohibited to be funded from the Economic Development Fund.

Section 2. Repealing Clause – All ordinances, resolutions, orders, memoranda and other issuances not inconsistent herewith are hereby repealed or modified accordingly.

Section 3. Separability Clause – If, for any reason, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 4. Effectivity – This ordinance shall take effect immediately upon its approval.


